

PRIVACY POLICY

This privacy policy statement describes how Majorpack Inc. collects and uses the personal information you provide on our Website: www.majorpack.com. It also describes the choices available to you regarding our use of your personal information and how you can access and update this information. When you visit our Website, we collect the following personal information from you, including, but not limited to:

Contact Information such as name, business affiliation, address (home, business, billing, or delivery), phone number, email address, and any personal details required to resolve any inquiries or complaints as allowed by applicable law

Unique Identifiers such as user name, account number, password

We automatically gather information about your computer such as your IP address, browser type, referring/exit pages, date, time, duration of your visit, operating system and other information about your computer or device. Information collected is used to respond to customer service requests, administer your account, process your transactions, update your account records, to inform you of other services that may be of interest, and to ensure compliance with appropriate regulations.

Information Sharing

We will share your personal information with third parties only in the ways that are described in this privacy policy statement. We do not sell your personal information to third parties.

We may provide your personal information to companies that provide services to help us with our business activities such as processing orders or offering customer service. These companies are authorized to use your personal information only as necessary to provide these services to you.

We may also disclose your personal information:

As required by law such as to comply with a subpoena, or similar legal process

When we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request

If Majorpack Inc. is involved in a merger, acquisition, or sale of all or a portion of its assets, you will be notified via email and/or a prominent notice on our Website of any change in ownership or uses of your personal information, as well as any choices you may have regarding your personal information

To any other third party with your prior consent to do so

Cookies and Other Tracking Technologies

We use another company to place cookies on your computer to collect non-personally identifiable information to compile aggregated statistics for us about visitors to our site. Our Webpages may also contain electronic images known as Web beacons (sometimes called single-pixel gifs) that are set by our third party partners. Web beacons are used along with cookies enabling our partners to compile aggregated statistics to analyze how our site is used. We use a third party service provider to gather information about how our customers use our Website, such the links they clicked on. We use this information to understand and optimize how our site is used.

Links to Other Websites

Our Website includes links to other Websites whose privacy practices may differ from those of Majorpack Inc. If you submit personal information to any of those sites, your information is governed by their privacy policy statements. We encourage you to carefully read the privacy policy statement of any Website you visit.

Security

The security of your personal information is important to us. When you enter sensitive information (such as credit card numbers or banking information) on our order forms, we encrypt the transmission of that information using secure socket layer technology (SSL). We follow generally accepted industry standards to protect the personal information submitted to us, both during transmission and once we receive it. No method of transmission over the Internet, or method of electronic storage, is 100% secure, however. Therefore, we cannot guarantee its absolute security and we cannot be held responsible for unauthorized or unintended access that is beyond our control.
